### Call to Order

The meeting was called to order by Chairman, Jim Albrecht at 10:01 A.M.

# **Approval of Minutes**

Erik Barner motioned to approve the July 13, 2023, amended board meeting minutes. Joel Brown seconded the motion. The motion carried unanimously.

# **Financial Reports**

Venture and Credit Analyst, Samantha Mattson discussed the financial reports. The Yearly Board Financial document was presented.

## **Current Pipeline**

Venture Financing Manager, Hannah Lange went over the deals in the Primary Sector pipeline.

Ms. Mattson went over the deals in the Childcare pipeline.

## Fertilizer RFP

Head of Investments and Innovation, Shayden Akason, presented the guidelines for the Fertilizer Loan Fund Program. The board shared concerns about their role in the process. Mr. Akason stated he would outline more ways the board could be a part of the process and bring them back to the board.

# **Closing Fund Outline**

Mr. Akason presented the outline of the Closing Fund Program that staff created. He noted the program is based off of other states programs to help us compete. The board had questions such as who this program is targeted for, what is the approved funding intended to accomplish, what stage of the project does it need to be in, and the

board's funding limits. Mr. Akason stated he would tighten up the language and detail of the outline and represent it to the board.

### **Other Business**

Erik mentioned he received phone calls about Summers Manufacturing and didn't know any of the updates on their situation. Mr. Akason replied he recently became aware of an acquisition from an Iowa company, and he received a settlement agreement. The lawyers are working out the details of the collateral stack to try and get NDDF some of the funds before the agreement will be signed.

Mr. Akason provided an update on Jessica's family. He provided ways people can help and a timeline of her return.

# **October In-Person Board Meeting**
