### LMI & WIOA UPDATE February 2025 LMI Report Phil Davis

Phil talked about the Labor Market Report for February 2025

- ND Unemployment Rate for February = 2.5% vs. 3.8% nationwide.
- ND Labor Force Participation Rate = 68.4% vs. 62.5% nationwide.
- The top 5 occupational groups with open jobs for February are: Healthcare, Farm, Fishing, & Forestry, Construction, Transportation, Sales & Related.
- Open jobs in ND = 16,630
- 10.7% up from January 2025
- .9% down from February of last year
