# WIOA POLICY UPDATE/OTHER

### Phil Davis

The Department of Labor (DOL) will conduct an audit th 3<sup>rd</sup> week in August and will review policy and procedures for WIOA. The four policies Phill presented to the council were pre-approved by the administrative committee and reviewed by the executive committee.

- Adult Dislocated Worker Funding language modifications from the Dislocated Worker Policy to the Adult Dislocated Worker Policy were made.
- **Common Exit** no changes
- **Data Validation** auditing of policies and validating. Language modifications to the policy were made.
- Individual Training Account no changes

Other:

- Job Service ND held a virtual job fair on March 14<sup>th</sup>; a multi-industry fair with 200 attending, and 70 employers attending. The next job fairs will be hosted in the next 6 weeks by Dickinson, Minot, Fargo, Williston, Grand Forks, and Devils Lake.
- Job Service ND Job Pod has held three podcasts so far.
- February job openings 17,000, with Cass County job openings at 4,800; Burleigh County job openings at 2,800; and Grand Forks County job openings at 1,400.

HB 1018 Department of Commerce Appropriations

- Regional Funding: \$20M + 1 FTE request; \$15M House + 1 FTE
- Talent Attraction: \$25M + 1 FTE; \$8M House + 1 FTE

- Automation Workforce Grant: \$5M; House \$5M

- House Added: \$2M for New American Workforce Training & Internship Grant

## CTE – Wayde Sick

HB 1019 NDCTE Appropriations Bill

- 2 additional FTEs (asked for 4)
- \$4M for cost to continue (current ask)
- \$8M\* for new and expanding programs (asked for \$20M, Governor included \$10M)
- \$500,000\* to fund Career Advisors (asked for \$3M)
- \$1.5M\* to fund Work-based Learning Coordinators (asked for \$3M)
- \$200,000 added to Emerging Technology (didn't ask for, the bill carrier added it)
- The CDE budget was zeroed out because if SB2269 passes, it will move over the DPI.
- The \$40M\* for overage/inflationary costs was zeroed out, but I was informed this will come back on the Senate side, once the March revenue forecast comes out.
- The \$20M for additional CTE Center Capital projects was zeroed out. This will be discussed after crossover
- The \$2M increase to TrainND was not included.
- **HB 1178** Higher Ed, Private, Parochial, and/or Private Sector to be represented on a CTE Board.
- **HB 1199** NDCTE with loan authority to carry out the CTE Capital Projects Program.

HB 1232 Continuation of the Legacy Fund earnings framework in 2021.

HB 1382 State Scholarship to be used for Registered Apprenticeship expenses.

HB 1519 Appropriate \$1M to NDCTE, grant out for UAS workforce training

**SB 2145** Emerging Digital Academy to operate without national accreditation.

**SB 2170** Minor under the age of 18 to be on a construction site with parental approval.

### DPI - Jim Upgren

HB 1219 & SB 2258 Both relate to retired teachers able to come out of retirement to teach in critical need areas without disruption to retirement benefits - Both passed

HB 1240 Career Builders Scholarship & Loan Repayment – Defeated House

HB 1305 ASVAB & other Choice Ready indicators with State Scholarship – Passed House

HB 1382 State Scholarship to be used for State Apprenticeship – Passed House

HB 1451 Increase amount of the State Scholarship – Defeated House

SB 2032 Paraprofessional to Teacher Grants – Passed Senate

SB 2033 Teacher student loan forgiveness for teachers in the 5 most critical need teaching areas - Passed Senate

SB 2340 Related fields to serve in schools & count towards the student to counselor ration – Passed Senate

# DPI Adult Education - Stan Schauer

SB 2013 – NDDPI Appropriations Bill

#### Voc. Rehabilitation - Damian Schlinger BUDGET

- Pre Employment Transition Students will have \$1M more to expand career exploration services for schools we can take this duty off the existing school staff and outsource it for free.
- Senior Community Service Employment Program help train workers 55 and older and reintroduce to the workforce let any business know looking for help that we pay these workers as they work at your business to gain skills.
- Independent living centers asking for more funding outside of the voc rehab bill.

**HCR 4004** Study transportation barrier for people w/disabilities – often this is the only barrier that exists for a person to work, not talent, not skill, not dedication, just getting there because due to their disability.

HB 1169 Parent, spouse, guardian, caregiver can park in accessible parking spaces.

**HB 1244** Customized employment/supported employment tax credit for businesses – 74 took advantage last biennium and cap of 100 has been removed, no sunset. Will be able to help as many businesses as possible find employees.
