### **WDC BYLAW UPDATE**

#### Katie Ralston Howe

Bylaws were updated in January to reflect an audit change that was required by the Department of Labor last autumn.

Changes include:

- 1. Designating a proxy in place of a member.
- 2. Notification to the Director by email.
- 3. Specify if the proxy is to vote in place of the member, if not specification is given, the proxy will not be allowed to vote.
- 4. One meeting a year will be allowed for this circumstance.

Circumstances will be handled on a case-by-case basis.

# LMI UPDATE for JANUARY 2024 Phil Davis

Phil talked about the top 5 occupational groups with open jobs

• Healthcare, Farm, Fishing & Forestry, Management, Sales & Related, Transportation.

Open jobs in ND = 14,859

5.1% less than January of last year

3.7% higher than prior month

Unemployment Rate = 1.7% current unemployment in December 2023 vs. 3.5% nationwide Labor Force Participate Rate = 67.8% ND vs. 62.2% nationwide

### Job Service Virtual Job Fair in January attendance:

97 employers

634 attendees, with almost 300 Philippinos.

### **Virtual Pavilions include:**

Healthcare Manufacturing government, education, and finance Oil, gas, skilled trades, and transportation The virtual job fair was promoted by social media and digital/radio ads. Partnered with Unemployment insurance with flyers sent to those on unemployment, and partner agencies of voc. rehab, adult ed, parks and rec, game and fish, and the Commerce Department with Find the Good Life.

### **Unemployment Insurance**

Vendor of Geographic Solutions – the vendor is the same one that we use for job openings. Those that use Jobsnd.com and ND Workforce connections. Those two systems will be tied together for those that need to look for work or submit a resume. The progress to join the two online may take up to four years.

# OFFICE OF LEGAL IMMIGRATION (OLI) UPDATE Katie Ralston Howe Dalberg and LaMP Consultants

In December, partners from Dalberg and Labor Mobility Partners (LaMP) consultant team came to the WDC meeting to work with Commerce for the study and development of goals for the OLI.

LaMP associate talked about the barriers to success, cultivate key learnings from other states, and propose initial recommendations. Dalberg & LaMP are currently in the 3<sup>rd</sup> part of Phase 1, with 125+ individual stakeholders consulted, 7 focus groups consulted during in-person workshops, 5 cities visited within ND, 2 workshops held with OLI and stakeholders, and 30+ reports and data sources reviewed.

Phase 1 key findings/recommendations will be brought to the April WDC meeting with the analysis and strategies of the report.

# NGA WINTER WORKFORCE POLICY INSTITUTE TAKEAWAYS Cindy Griffin Katie Ralston Howe

Katie and Cindy, along with Zac Greenberg from the Governor's Office attended the NGA Winter Workforce Development Policy Institute in Washington, DC on January 31<sup>st</sup> – February 2, 2024.

- ND continues to get recognition on the initiatives we are doing.
- ND selected for an NGA Workforce inclusion initiative.
- ND has active participants, with not all states having their chairs at the meeting.
- Childcare was a big topic and ND is aligned with how other states are moving.
- Economist describes ND as having a high growth rate, 1% percent growth is related to 4,000 workers
- WIOA reauthorization changes for ND
  - Change from 4-year state plan to a 2-year state plan
- Topics of interest were:
  - youth apprenticeship
  - career pathways
  - o federally approved registered apprenticeship program in Illinois, that is fostering entrepreneurship with food trucks
  - Wallet concept for childcare offset cost for workers
  - Spaces on colleges/universities for childcare
  - Al taskforces that are being formed.
  - Housing hotels being transformed into housing

# NGA DISABILITY INCLUSIVE WORKFORCE COLLABORATIVE Damian Schlinger

ND, along with six other states are accepted into the competitive collaborative. The collaborative timeline is January through June 2024. Team members & liaisons include: Voc Rehab, Job Service, Department of Commerce, DPI, Developmental Disabilities from HHS, HRMS, Governor's Office, and consultants.

Damian talked about demographics of the workforce, retired, disabled, caring for children, laid off, elderly and the talent pools; work age with disabilities, college graduates, high school graduates and incarcerated individuals released each year.

Workforce partners successes and opportunities:

- Co-enrollment across WIOA programs
- 22 states that have combined workforce systems
- Recent outreach with Job Service to employers
- Work Opportunity Tax Credit (WOTC) tax credits

Goals from ND's application; State as a Model Employer (SAME)

- 1. Develop tools for employers throughout the state
- 2. Skills based hiring model
- 3. Centralized accommodation fund for state and employers
- 4. Accommodations process and data
- 5. Remove barriers to application and interview by exploring different processes
- 6. Gain understanding of current market penetration of population with barriers
- 7. Behavior health initiatives
- 8. Programs to prepare young with significant disabilities for employment

The WIOA Unified State Plan is currently out for public comment; January 19 – February 18<sup>th</sup> and must be submitted via the Federal portal by March 4<sup>th</sup>, 2024. Every four years the WIOA Unified State Plan needs to be rewritten and updated every 2 years with the four agencies of Job Service ND, Voc Rehab, Adult Education, and the Commerce Department to receive federal funding for WIOA core programs.
